# Website Modernization Program

---

The Commonwealth of Virginia (COV) website modernization program was created to ensure all state websites provide an accessible, trusted and secure experience for all Virginians. Specifically, the program looks to aid agencies in meeting the COV web standards.

VITA is developing and testing an updated banner, similar to what can currently be found

at <https://www.developer.virginia.gov/downloads/commonwealth-banner/>. **Implementation of the banner is required for all main and sub-web pages.**

VITA is also developing a design system that includes style guides, templates and a consistent color palette. **Use of the design system is optional but recommended**, especially for agencies that have not updated their websites recently.

The Website Modernization Project Management Office (Web Mod PMO) team will coordinate deep dives with agencies through their customer account managers (CAMs) or directly for agencies without an assigned VITA CAM. The team will ensure remediation progress is tracked and reported.

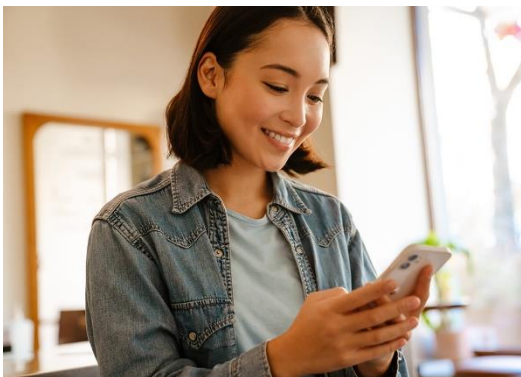
## Web Systems Standards

## FAQs

### **Who is providing governance and oversight for the program?**

The Website Modernization Program Management Office (Web Mod PMO team), situated within VITA, will provide governance and oversight support for this effort. The team works closely with the VITA Web Technologists team for accessibility and design standards.

### **Does every agency have to comply?**

Executive branch and independent authorities that report to the governor are in scope for this project. All Commonwealth of Virginia agencies should be striving towards accessible, trusted and secure websites.

### **What websites are considered in-scope?**

All public-facing websites and web applications are in scope. The Web Mod PMO team will work with agencies to evaluate non-government websites (.COM, .EDU, etc.) on a case-by-case basis.

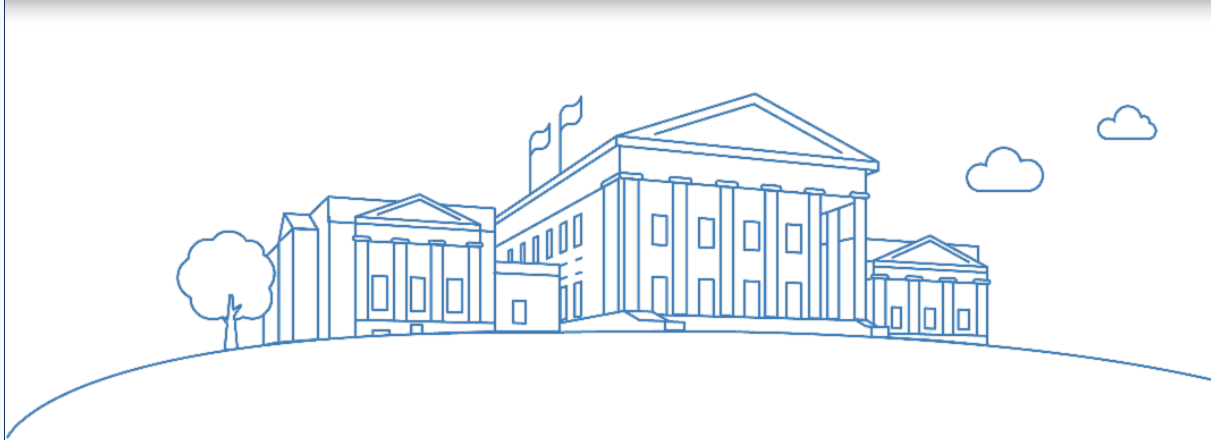
### **Is VITA going to assist agencies?**

VITA will provide a design system that will offer branded templates, a website compliance checklist and a process for approval before going into production of any new websites that do not leverage the Virginia.gov website solutions service. VITA is contracting with Accenture for nine months to develop the governance framework and provide accessibility training to agencies.

*Note: Accenture will not be performing the remediation work. VITA has existing contracts with three eGov vendors who provide full hosting and web maintenance support and three content management system (CMS) providers for agencies that just need the tools. VITA, through a new service manager (Virginia.gov website solutions), will act as a liaison between agencies and the service providers to find the best fit, depending on an agency's needs.*
